#### **DISCUSSION ITEMS**

#### 4. Update on COVID-19 Situation

A brief discussion ensued regarding impacts the current COVID-19 situation has had on stormwater programs and local government in general:

- Martelet mentioned that Carmel City Hall is opening back up to the public.
- Gomez shared that Sand City City Hall will remain on a hybrid model of opening with half of staff reporting in-person.
- Condit shared that he is in conversations with M1W on when we can have in-person meetings for our regional program.

#### 5. Presentation on PCR Testing and HF183

Monterey SEA welcomed Dr. Donna Fergusson and Dr. Audrey Levine for a presentation on Microbial Source Tracking and HF183. An extended discussion ensued.

#### 6. Update from Political Relevancy Workshop

Members provided feedback on the Political Relevancy Workshop that was held during the March 24 Management Committee meeting:

- Schneider shared that he felt it was a helpful workshop. He encouraged us to include it on our agenda going forward as it is hard to focus on our own time.
- Martelet shared that it was helpful and wanted to keep it on our agenda for future meetings.
- Trapani has been working to optimize political relevancy from the County perspective.

Condit shared next steps that came out of the Workshop regarding the Regional Program which include releasing a press release to focus on '20 Years of Collaboration' for the program, as well as to announce our new logo and website. The press release will be a starting point for a promotional brochure regarding accomplishments for the regional program along with resources for the public. The brochure can be distributed to stakeholders including City Councilmembers and Supervisors at future meetings. Condit will reach out to members to identify accomplishments for the program that will be included in the press release and brochure **(Action Item – Condit)**.

Members directed Sidenstecker to invest in T-Shirts (for volunteers), chico bags, etc. that showcase our new logo **(Action Item – Sidenstecker)**.

#### 7. Update on Annual Report

Condit shared a spreadsheet that included SMARTS Annual Report questions for Year 7 of the MS4 Permit. Members were encouraged to review the questions in preparation for the end of the Year 7 Permit Year. A brief discussion ensued.

Trapani asked whether there was guidance from the State Water Board regarding records retention for Annual Reports and other documents. Condit will research the issue and report back to members **(Action Item – Condit)**.

#### 8. Update on AB377

Condit provided an update on the status of AB377. The proposed bill was recently converted to a two-year bill, signifying the bill will not proceed to the full Assembly this year and will instead remain in the Assembly Appropriations Committee. As a two-year bill it will need to be approved by the Appropriations Committee and the full Assembly in a compressed timeframe (likely, by the end of January 2022).

**NOTICE IS HEREBY GIVEN** that the State Water Resources Control Board (State Water Board) will receive public comments on the proposed reissuance of the statewide National Pollutant Discharge Elimination System (NPDES) Construction Stormwater General Permit.

## **BACKGROUND**

The federal Clean Water Act requires discharges of construction stormwater to waters of the United States to be regulated by an NPDES permit. The State Water Board adopted the existing statewide NPDES Construction Stormwater General Permit in 2009 to regulate stormwater discharges associated with construction activities disturbing one or more acres. The existing Construction Stormwater General Permit expired on September 2, 2014 and is administratively extended until the effective date of a reissued permit.

The draft Construction Stormwater General Permit incorporates:

- New requirements to implement existing Total Maximum Daily Loads adopted by Regional Water Boards into applicable Basin Plans;
- New regulation of passive treatment technology uses and discharges from dewatering activities;
- New criteria for Notices of Non-Applicability;
- Efficiency to the existing Notice of Termination process;
- Requirements to implement the California Ocean Plan and the Water Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries, including the statewide Trash Provisions;
- Updated requirements for demolition activities;

- Updated water quality sampling requirements per the federal Sufficiently Sensitive Test Methods Rule; and
- Updated monitoring and reporting requirements.

State Water Board staff released an informal draft of the proposed Construction Stormwater General Permit on November 30, 2020, hosted two public workshops in December 2020 and held subsequent focused meetings with interested parties. Staff considered all informal public feedback in the development of the proposed permit.

### **PROCEDURAL MATTERS**

Due to ongoing circumstances related to the COVID-19 pandemic, the public workshops and public hearing are currently scheduled to be held remotely via an online platform. Instructions for participation in the workshops through the online platform will be distributed via email to registered participants.

During the public workshops, staff will present a detailed explanation of the draft Construction Stormwater General Permit and changes made in consideration of feedback received on the informal draft. Participants will have the opportunity to ask staff detailed questions regarding the draft Permit during the public workshops.

At the State Water Board public hearing, there will be no sworn testimony or cross-examination of participants. However, the State Water Board and its staff may ask clarifying questions. Participants will be given an opportunity to provide oral presentations. To ensure a productive and efficient hearing in which all participants have an opportunity to participate, oral presentations may be time limited.

**NOTICE IS HEREBY GIVEN** that Central Coast Regional Water Quality Control Board (Central Coast Water Board) staff will hold a public workshop to seek input on proposed additions and revisions to the Clean Water Act sections 303(d) List and section 305(b) Water Quality Report. California combines its 303(d) List and 305(b) Report into a single "California Integrated Report."

#### BACKGROUND

The State Water Board, along with the Regional Water Quality Control Boards, is developing the 2020-2022 Integrated Report. The Integrated Report is comprised of a list of the state's impaired waters (Clean Water Act (CWA) section 303(d) List) and a report on the condition of its surface waters (CWA section 305(b) Report). The CWA requires the states to submit this information to the USEPA every two years.

<sup>1</sup> As a result of the COVID-19 emergency and the Governor's Executive Orders to protect public health by limiting public gatherings and requiring social distancing, this meeting will occur solely via remote presence.

The California Integrated Report is developed in “listing cycles.” To develop the 303(d) List, the State and Regional Water Boards review available data and evaluate whether or not local surface waters meet applicable water quality standards. Each listing cycle consists primarily of assessments from the three of the nine Regional Water Boards. The 2020-2022 listing cycle focuses on the Central Coast Region as well as the San Diego and Central Valley Regions. Data solicitation for this cycle occurred from December 2018 to June 2019 and included data collected between 2010 and July 2019.

The State Water Board will release a 2020-2022 Integrated Report staff report for public review and comment on the proposed changes to the California Integrated Report on or before June 4, 2021. This staff report will be available on the State Water Board [website](#). You may request a paper copy of the draft staff report by contacting Keara Tusso at [keara.tuso@waterboards.ca.gov](mailto:keara.tuso@waterboards.ca.gov).

## PURPOSE

This meeting will provide participants with 1) an overview of the 2020-2022 Integrated Report staff report and proposed additions and revisions to the California Integrated Report and 2) an opportunity to comment and ask questions.

Central Coast Water Board staff will consider the issues raised and comments provided by attendees of the remote video and teleconference in preparing the final reports that will be presented to the State Water Resources Control Board.
