4. Update on COVID-19 Situation

MRSWMP MC Meeting Minutes

A brief discussion ensued regarding impacts the current COVID-19 situation has had on stormwater programs and local government in general:

 Trapani shared that the County has tightened Covid protocols and has the majority of its staff working from home.

5. De-Brief of December 17 MRSWMP Meeting and Site Visits

Members shared their experience with the December 17 MRSWMP Meeting which included site visits to the Pacific Grove Virtual Coastal Tour and the Pacific Grove/Monterey ASBS Wet-Dry Weather Stormwater Capture/Diversion Project. Feedback of the meeting was positive, with members sharing that it was a productive use of time. Members suggested that it would be beneficial to pursue additional site visits on an annual basis, when an appropriate topic can be further explored on the ground.

- 6. Presentation on the City of Seaside's Plastics Pollution Prevention Initiative
 Jo Fleming and Brooke Wright of Environmental Innovations provided a presentation on
 their efforts to promote Plastics Pollution Prevention ordinances (ie. bans on single-use
 foodware) throughout Northern California. They are currently working with the City of
 Seaside on implementing their Plastics Pollution Prevention Ordinance. They have
 developed a Turn the Tide on Plastic logo that may be a fit for regional efforts. Issues that
 have arisen in the City of Seaside include the lack of water credits for some restaurants to
 switch to reusable foodware and the fact that the biodigester at the landfill is no longer
 operational. There may be an opportunity to leverage the Green Business Program and
 their rebate program to promote alternatives to single-use foodware.
- 7. Presentation on the City of Monterey's Storm Drainage Maintenance Plan Wotan provided a presentation on the City of Monterey's Storm Drainage Maintenance Plan. She provided an overview of the regulatory process involved, highlights of the plan and deliverables, and lessons learned. Wotan will forward a copy of the SDMP to Condit who will forward to the group (Action Item Wotan, Condit).

8. Update on MRSWMP Monitoring Program

- a. Discussion of Trend Analysis of MRSWMP Monitoring Program Data Condit presented a Staff Report that contained a draft outline of the upcoming Trend Analysis of MRSWMP Monitoring Data which members approved during the November 18, 2021 MRSWMP Meeting. Members reached consensus to develop a Sub-Committee to work with the Monterey Bay Marine Sanctuary Foundation to oversee the analysis. Wotan and Trapani volunteered to serve on the Sub-Committee.
- b. Discussion of Results of Cypress Tree Sampling and Next Steps Martelet shared that she partnered with the Monterey Bay Marine Sanctuary Foundation to conduct sampling near cypress trees during the current rain season. Her motivation was to identify a possible source of surfactants that have been found during MRSWMP monitoring events. The initial investigation found surfactants in the sample taken from runoff from a cypress tree. Members directed Condit to work with Lisa Emanuelson to develop a proposal for cypress tree sampling that will be brought back to the group (Action Item – Emanuelson, Condit).

Background

The MRSWMP Program has participated in the Our Water, Our World initiative since 2006. Starting in January 2022, the initiative will be facilitated by the California Stormwater Quality Association (CASQA), requiring the purchase of an annual license for continued participation.

Discussion

The Our Water, Our World (OWOW) program is an award-winning partnership between cityand county-based water pollution prevention programs and garden centers and hardware stores that sell pest control products. Initiated in 1998, the program focuses on less-toxic, eco-friendly products and techniques as many common pesticides are harmful to sensitive species and ecosystems when they reach local creeks, bays, and the ocean.

In addition to working with the program to raise public awareness of this important issue, the MRSWMP Program has utilized the OWOW program to meet specific Community-Based Social Marketing requirements under the Phase II MS4 Permit.

Our Water, Our World directly reaches consumers at the point of sale and consists of several program elements:

In-Store Educational Materials

In the store, consumers are directed to less-toxic products and techniques through a variety of ways:

- Fact sheets are provided to educate the public on a wide range of pest management topics
- Shelf tags and display materials guide customers to less-toxic products
- Additional educational resources are provided, such as product lists and information about active ingredients in pest management products

Integrated Pest Management (IPM) Advocates

A critical component of the program, IPM Advocates are individuals who have been specifically trained on how to engage with retailers and the public. IPM Advocates provide in-store presentations and help for customers about pest management methods that are healthier for people and the environment. IPM Advocates also provide training for store employees. The MRSMWP PE/PO Coordinator is a trained IPM advocate.

Trade Shows

Our Water, Our World exhibits annually at trade shows to educate buyers on less toxic products.

Our Water, Our World started as a pilot project in 1998, in just a handful of stores, initiated by the Contra Costa County Sanitation District, the City of Palo Alto Regional Water Quality Control Plant, and the Marin Countywide Stormwater Pollution Prevention Program.

The program quickly grew and was administered by the former Bay Area Stormwater Management Agencies Association from 1999 – 2021. During that time, over 130 agencies in 16 counties implemented the program, working in approximately 239 stores.

Starting in January 2022, the program was transferred to CASQA, with the goal of providing statewide access to this important and successful outreach program.

Fiscal Implications

The annual license for a Group Subscription through CASQA is \$2,085. There is a sufficient balance for this unplanned proposal in the MRSWMP contingency budget.

Recommendation

Staff recommends the Management Committee approve the purchase of an initial annual license for the Our Water, Our World program from CASQA, funding the initiative through the MRSWMP contingency fund. In the future, this item can be budgeted within the Public Education and Public Outreach annual program budget.

Subject: Action Item to Approve Cypress Tree Sampling

Background

The City of Carmel recently partnered with the California Marine Sanctuary Foundation (CMSF) to conduct sampling near cypress trees during the current rain season. The motivation was to identify a possible source of surfactants that have been found during MRSWMP monitoring events. The initial investigation identified surfactants in the sample taken from runoff from a cypress tree. MRSWMP Members shared an interest in exploring this matter further to validate the initial findings.

Discussion

The California Marine Sanctuary Foundation has developed a proposal to address MRSWMP's need for surfactant monitoring from area cypress trees during wet weather events. To achieve this goal, CMSF staff will conduct wet weather monitoring to collect three rainfall runoff samples per site from the trunks of local trees (Monterey cypress, Monterey pines, and oak trees). CMSF staff will visit three sites:

- Mission Trail Nature Preserve in Carmel (within 1 mile of the ocean)
- Rip Van Winkle Open Space in Pacific Grove (within 1 mile of the ocean)
- Ryan Ranch in Monterey (within 3 miles of the ocean)

Samples will be tested for MBAS surfactants, orthophosphate, and nitrate.

Fiscal Implications

The CMSF Proposal for cypress tree sampling is \$2,891. There is a sufficient balance for this unplanned proposal in the MRSWMP contingency budget.

Recommendation

Staff recommends the Management Committee approve the CMSF proposal for cypress tree sampling, funding the initiative through the MRSWMP contingency fund.
