DISCUSSION ITEMS

4. Update on COVID-19 Situation

A brief discussion ensued regarding impacts the current COVID-19 situation has had on stormwater programs and local government in general.

5. Presentation from City of Paso Robles: PCR Alternative Compliance

David LaCaro of City of Paso Robles and Avery Blackwell of Geosyntec provided an overview of their Alternative Compliance program for the Post-Construction Requirements. The program attempts to serve as a win-win-win scenario for the City, Regulators, and Developers by doing the following:

- Increase City-wide watershed benefits
- Increase opportunities to cost-effectively build out urban areas
- Save the City ongoing administrative costs and time

They have currently identified four high priority projects out of a possible 27 projects that could be utilized toward Alternative Compliance.

Key takeaways from their program include:

- Cities have the ability to leverage developer funds to develop green infrastructure
- Focus on benefits rather than compliance
- Dust off the previous plans
- Quantify for competitive projects
- Limit City risk

6. Update on Sand City Prop 1 Grant: West End Stormwater Improvement Project

The City of Sand City was successful in its efforts to secure a Prop 1 Stormwater Grant to implement the West End Stormwater Improvement Project. Gomez shared highlights of the project which will retrofit an existing urban collector street to integrate LID features, address flooding and promote sustainable water management, while benefitting a Disadvantaged Community (DAC).

LID strategies to be implemented include:

- Bioretention facilities and curb extensions at intersections to capture runoff
- Horizontal infiltration chambers and trash capture devices
- Permeable pavement in parking and sidewalk areas and at intersections
- New storm drain infrastructure and routing
- Abandonment of existing storm drain lines

7. Update on Political Relevancy Workshop - March 24

Monterey SEA will host a Political Relevancy Workshop for members during our March 24 Management Committee meeting. The Workshop will review the political relevancy of the Monterey SEA program as a Case Study. The Workshop will then provide members with an opportunity to review the political relevancy of individual programs.

8. Update on Public Outreach and Public Education

a. Update from Web Re-Design Sub-Committee

Condit and Sidenstecker are working with our web consultants to re-design the MontereySEA.org website with a new look in line with the new logo.

Sidenstecker shared that she is working with a group of students to develop TikTok videos with a focus on water quality issues.

9. Update on Trash Amendment

Condit shared that he is currently conducting Trash Assessments on behalf of jurisdictions utilizing the 2NForm Trash RAM platform. He will notify members prior to conducting the assessments (Action Item – Condit).

- **a.** <u>City of Monterey</u> Wotan shared that the City is developing a full trash capture project in her downtown core.
- **b.** <u>City of Seaside</u> Ottmar shared that the Campus Town development has submitted their first phase of planning documents, overcoming a legal challenge.
- **c.** <u>City of Carmel</u> Martelet shared she has three projects that have triggered the PCR requirements.
- **d.** <u>City of Pacific Grove</u> Schneider shared that the Stormwater Capture project at the golf course is moving forward with no issues.
- **e.** <u>County of Monterey</u> Trapani shared that he is focused on an effort to map the County's storm drain system.
- f. <u>Program Manager</u> Condit shared that CASQA is hosting a Town Hall meeting regarding the proposed bill, AB377. He will forward the information regarding the Town Hall to members.



Monterey SEA's Position Regarding AB377

Background

A comprehensive bill regarding stormwater regulation was recently introduced by Assembly Member Robert Rivas (Hollister). The bill currently resides in the Committee on Environmental Safety and Toxic Materials. Monterey SEA has the opportunity to draft a letter stating its position regarding AB377.

Discussion

Bill Summary (as provided in AB377)

Under existing law, the State Water Resources Control Board and the 9 California regional water quality control boards regulate water quality and prescribe waste discharge requirements in accordance with the federal national pollutant discharge elimination system (NPDES) permit program established by the federal Clean Water Act and the Porter-Cologne Water Quality Control Act. Existing law requires each regional board to formulate and adopt water quality control plans for all areas within the region, as provided.

This bill would require all California surface waters to be fishable, swimmable, and drinkable by January 1, 2050, as prescribed. The bill would prohibit the state board and regional boards from authorizing an NPDES discharge, or a waste discharge requirement or waiver of a waste discharge requirement for a discharge, to surface water that causes or contributes to an exceedance of an applicable water quality standard in receiving waters, or from authorizing a best management practice permit term to authorize a discharge to surface water that causes or contributes to an exceedance of an applicable water quality standard in receiving waters. The bill would prohibit, on or after January 1, 2030, a regional water quality control plan from including a schedule for implementation for achieving a water quality standard that was adopted as of January 1, 2021, and would prohibit a regional water quality control plan from including a schedule for implementation of a water quality standard that is adopted after January 1, 2021, unless specified conditions are met. The bill would prohibit an NPDES permit, waste discharge requirement, or waiver of a waste discharge requirement from being renewed, reissued, or modified to contain effluent limitations or conditions that are less stringent than those in the previous permit, requirement, or waiver, except as specified.

Existing law authorizes the imposition of civil penalties for violations of certain waste discharge requirements and requires that penalties imposed pursuant to these provisions be deposited into the Waste Discharge Permit Fund, to be expended by the state board, upon appropriation by the Legislature, for specified purposes related to water quality. For violations of certain other waste discharge requirements, including the violation of a waste discharge requirement effluent limitation, existing law imposes specified civil penalties, the proceeds of which are deposited into the continuously appropriated State Water Pollution Cleanup and Abatement Account, which is established in the State Water Quality Control Fund.

This bill would require, by January 1, 2030, the state board and regional boards to develop an Impaired Waterways Enforcement Program to enforce all remaining water quality standard violations that are causing or contributing to an exceedance of a water quality standard. To ensure any water segments impaired by ongoing pollutants are brought into attainment with water quality standards, the bill would require the state board and regional boards, by January 1, 2040, to evaluate the state's remaining impaired waters using a specified report. The bill would require, by January 1, 2040, the state board and regional boards to report to the Legislature a plan to bring the final impaired water segments into attainment by January 1, 2050. The bill would create the Waterway Attainment Account in the Waste Discharge Permit Fund and would make moneys in the Waterway Attainment Account available for the state board to expend, upon appropriation by the Legislature, to bring remaining impaired water segments into attainment in accordance with the plan. The bill would create in the Waterway Attainment Account the Waterway Attainment Penalty Subaccount, composed of penalties obtained pursuant to the Impaired Waterways Enforcement Program, and would make moneys in the subaccount available for the state board to expend, upon appropriation by the Legislature, for purposes of the program. The bill would require, by January 1, 2040, and subject to a future legislative act, 50% of the annual proceeds of the State Water Pollution Cleanup and Abatement Account to be annually transferred to the Waterway Attainment Account. The bill would require the state board, upon appropriation by the Legislature, to expend 5% of the annual proceeds of the State Water Pollution Cleanup and Abatement Account to fund a specified state board program.

CASQA's Analysis / Key Aspects of AB377i

- Prohibits the State and Regional Boards from adopting NPDES permits with compliance schedules or deemed compliance terms
- Requires end of pipe monitoring, comprehensive antidegradation analysis, and establishes a state law anti-backsliding provision
- Limits the amount of time that can be included in Schedules of Implementation in Water Quality Control Plans and limits use of time schedule orders (TSOs) to no longer than until 2030 (significant impact to TMDL compliance schedules, both existing and any TMDLs to be adopted)
- Requires development of an Impaired Waterways Enforcement Program to enforce all water quality standards violations
